## Application Terms & Conditions

### TERMS AND CONDITIONS

1. Offer open to all South Jersey Gas (SJG) Residential Customers for qualified new appliances purchased and installed beginning July 1, 2021, through June 30, 2024.
2. Limit one rebate per qualified clothes washer and/or dryer per SJG residential account.
3. SJG gas residential account must be active at the time of purchase for the installation address associated with this application for appliance to be eligible for rebate.
4. All rebated appliances must be installed and used at the service (installation) address specified on the rebate application.
5. The completed rebate application and all required documents must be received within 90 days of purchase.
6. Rebate applications must be postmarked or electronically submitted by July 15, 2024.
7. Rebate application with valid customer account number must be accompanied by a legible copy of the paid itemized sales receipt showing proof of purchase that includes manufacturer, store name and location, purchase price and date of purchase.
8. It is the responsibility of the applicant to make sure all Program requirements are met and all required documentation is provided to SJG. Failure to provide required documentation will prevent processing of the application.
9. The rebate paid will not exceed the purchase price of the appliance.
10. Rebate will be issued to the account holder and mailing address on record with the utility.
11. Please allow up to 60 days to receive the rebate after completed documentation is received.
12. By participating in the Company's energy efficiency and peak demand reduction programs, customers agree their electric utility will maintain ownership of all Capacity Rights from electric savings measures, which refers to the demand reduction associated with any energy efficiency and peak demand reduction measure for which incentives were provided by the Company. Your electric utility will aggregate these energy efficiency demand reduction attributes into the PJM capacity market as appropriate, with proceeds being used to reduce customers' costs for the programs.
13. SJG and/or their designees including program administrators and evaluation contractors reserve the right to review installations to verify completion and measure energy savings to ensure compliance with all program requirements. Such reviews may require reasonable access to installations and will be made at a time convenient to the applicant. Misrepresentation of installation location or measure eligibility may result in forfeiture of the rebate.
14. This Program is subject to New Jersey Board of Public Utilities (NJBP) regulatory rules and orders. SJG reserves the right to change any portion of the Program or end this program without notice.

### Tax Information

Rebates may be subject to federal and/or state income tax reporting. Rebate recipients are responsible for contacting a qualified tax advisor to determine tax liability. SJG is not responsible for any tax consequences of the rebate program.
