

# HVAC AND WATER HEATING Rebates up to \$1,500 and 0% APR Financing



As much as half of the energy used in your home goes toward heating and cooling.\* Making smart decisions about your home's heating, ventilating, and air conditioning can have a big effect on your utility bills.

Installing energy-efficient equipment has never been easier or more affordable. When you upgrade your HVAC and/or water heating system to high efficiency, you may be eligible for rebates and incentives for each piece of qualifying equipment. This includes rebates up to \$1,500 on select HVAC equipment and up to \$15,000 at 0% APR financing for 7 years through our On-Bill Repayment Program (OBRP).\*\*

#### Participation is Easy

You must be a South Jersey Gas (SJG) residential account holder at install address.

- **1.** Choose the recommended energy-saving improvements you want to make.
- **2.** If you plan to finance the project, an SJG Participating Contractor is required.
- **3.** Schedule an appointment with the contractor at a time that is convenient for you.
